

OFFICIAL SWEEPSTAKES RULES

1. SPONSOR AND ADMINISTRATOR.

2. ELIGIBILITY.

Open to legal residents of the fifty (50) United States and the District of Columbia, who are at least eighteen (18) years of age and the age of majority in their state of residence at time of entry.

Employees, directors, representatives, and agents of CPTS and its parent, affiliates, and subsidiaries, and each member of their immediate family (spouse, parent, children and siblings and their respective spouses, regardless of where they reside) and/or those persons living in the same household, whether or not related, are NOT eligible to enter or win a prize.

3. GIVEAWAY PERIOD.

The CPTS Meta AI Glasses Giveaway (the “Giveaway”) commences at 12:00 P.M. Eastern Standard Time (“EST”) on Friday, May 1, 2026, and concludes at 11:59 P.M. EST on Thursday, May 21, 2026 (the “Giveaway Period”). Entries that are received before or after the Giveaway Period will be disqualified.

Entrant will be required to provide information, including but not limited to the Entrant’s full name, physical address (no P.O. Boxes permitted), date of birth, and email address. Any incomplete or unintelligible Entries, or Entries generated by a script, macro, or other automated means, will be disqualified at the sole discretion of CPTS.

Entries are void if (i) not obtained or submitted in accordance with these Rules, or (ii) are obtained as the result of or in connection with a sale, transfer, or other method which we determine, in CPTS’ sole discretion, is in violation of these Rules. CPTS reserves the right to audit Accounts at any time and has the right to request proof of your Entry.

5. GIVEAWAY DRAWING AND ODDS OF WINNING.

The Giveaway Drawing (“Drawing”) will be conducted by CPTS, from among all eligible Giveaway Entries received during the Giveaway Period. Odds of winning depend on the total number of eligible Giveaway Entries received.

6. PRIZE AND APPROXIMATE RETAIL VALUE.

There is one (1) Prize available to be awarded. The Prize Winner will receive one (1) pair of AI-enabled smart glasses, selected by the Prize Winner from one (1) of the following four (4) options: Ray-Ban Meta Wayfarer (Gen 2), Ray-Ban Meta Skyler (Gen 2), Ray-Ban Meta Headliner (Gen 2), or Oakley Meta HSTN Glasses (collectively, the "Prize Options"), subject to availability at the time of selection. The Prize Winner will be permitted to select, as part of their Prize Option, available frame colors and non-prescription lens options (including lens color) offered by the manufacturer for the selected model at the time of Prize fulfillment, subject to availability and the maximum ARV of the Prize stated herein. All selections are subject to the final approval of the CPTS in its sole discretion.

The Prize shall consist solely of the selected AI-enabled smart glasses and any standard manufacturer-included accessories packaged therewith at the time of purchase.

Winner will be contacted by a CPTS representative to confirm shipping details.

The total approximate retail value (ARV) of the Prize will vary depending on the Prize Option selected by the Prize Winner but shall not exceed \$550. Actual ARV may vary based upon model configuration, applicable sales tax, and the cost of shipping the Prize to the Winner.
